
represent the whole European gas sector. “I strongly believe that we need to speak with one voice to be able to guide the gas sector through these important years of transformation. We are part of the solution.”

Important legislative decisions will be made in Brussels in 2021. Ms Summers will advocate for gas to play a key role in reaching the 2030 targets and achieving climate neutrality by 2050. The gas sector offers innovative and cost-effective solutions on the way to climate neutrality, with both decarbonised and renewable gases, she argued. However, only a technology-neutral approach will unlock the sector’s full potential in Europe.

Dawn Summers has been the COO of Wintershall Dea since 1 June 2020 and is responsible for Europe, Middle East and North Africa. She has more than 25 years of international experience in the gas and oil sector, including with BP, Genel Energy, Origin Energy and Beach Energy.
