DEA in the era of National Socialism

Take responsibility, share knowledge and learn for the future. This is the motto under which Wintershall Dea AG has been critically examining its company history for several years. We are now taking the next step.

Following the publication of "Expansion at all costs" (2020) with studies on the history of Wintershall AG in the period of National Socialism, we have commissioned the German Gesellschaft für Unternehmensgeschichte (GUG, "Business History Society") to also reappraise the role of our second predecessor company DEA during this time. The reason for this is that DEA was also involved in the German autarky and economic policy between 1933 and 1945 and benefited from National Socialist expansionism.

The renowned economic historians Dr Rainer Karlsch and Professor Manfred Grieger have been researching the extent of that involvement since spring 2022. We want to now present the first research results at a historical conference – and relate the new findings to other current research projects on the oil industry during the Nazi period. We therefore welcome scientists from the Hamburg Foundation for the Promotion of Science and Culture and the Institute for Didactics of Democracy (IDD) at the Leibniz University Hannover. In a research project funded by the Ministry of Science and Culture of the State of Lower Saxony, the IDD team is currently investigating the political, social and economic conditions and effects of crude oil production in the Celle region between 1933 and 1945 and in the post-war era.
